In 2024 the Parent Payment contributions are categorised as follows:

- 1. Curriculum Contributions;
- 2. Other Contributions; and
- 3. Extra Curriculum Items and Activities.

### 1. Curriculum Contributions

Curriculum Contributions (previously known as Essential Student Learning Items) support items and activities that help deliver fundamental curriculum or subject learning. These include general classroom materials and a charge for ICT equipment and associated technology such as the purchase and maintenance of devices for use in classrooms, along with peripherals and connectivity.

### 2. Other Contributions

Other Contributions (previously known as Voluntary Contributions) support four areas of the school's operation, to improve learning outcomes.

The Victorian Department of Education provides funding to schools through the School Resource Package (SRP) that is supplemented through locally raised monies via fundraising, the hire of facilities and family contributions. The SRP includes funding for staffing, the <u>standard curriculum program</u>, equipment, and operational costs such as utilities, maintenance/urgent works and resources and cleaning. Approximately 90% of the SRP funding is required to cover the cost of the employment of staff. This leaves just 10% to meet all other operational costs, maintenance of our facilities and curriculum opportunities, so we appreciate additional contributions from parents and carers.

We are extremely grateful to all our school families who have paid their 2023 school fees which has made an enormous difference to our school.

In 2024 we will require your support again as we have major plans to continually improve our school and make a significant difference to the education we provide.

#### 3. Extra-Curricular Items and Activities

Payments for Extra-Curricular Items and Activities (previously known as Optional Items) provide for items and activities over and above what is needed to deliver fundamental curriculum learning.

Excursions, incursions, camps and sports will be charged separately for students as needed through the Compass portal.

### FREE INSTRUCTION

- Schools may invite parents to make a financial contribution to support the school.

### **PARENT PAYMENT REQUESTS**

Schools can request contributions from parents under three categories:

# Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

## Other Contributions

Voluntary financial contributions for noncurriculum items and activities that relate to the school's functions and objectives.

Extra-Curricular Items and Activities Items and activities Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.



• Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).

### FINANCIAL HELP FOR FAMILIES



- Schools put in place financial hardship arrangements to support families who cannot
  pay for items or activities so that their child doesn't miss out.
